## Mineage.

This family deduces its descent from Thomas de Moore, one of the knights who accompanied the Conqueror into England, and who survived the decisive battle of Hastings, in which he had a principal command. About the middle of the 14th century the ancestors of the earl were seated in the west of England, and in the beginning of Queen Elizabeth's reign, they purchased an estate near Larden, co. Salop, whence, for nearly a century, they were designated the Mores of Shropshire. (See Burke's Landed Gentry, article "More of Linley.") In the reign of King James I.,

RICHARD MOORE emigrated to Ireland, and fixed his abode at Clonmell. This gentleman left two sons; the elder of whom,

STEPHEN MOORE, Esq., purchased the estate of Kilworth, co. Cork, and settled there. Mr. Moore had the honour of being personally known to King William, to whom, upon that prince's arrival in England, he lent £3000, which sum was never refunded; he was, however, constituted by his majesty, governor of the co. Tipperary, and colonel of its militia. He m. Miss Croke, dau. or granddau. of Sir George Croke, lord-chief-justice of the King's Bench in England, by whom he had an only son,

RICHARD MOORE, Esq., who m. Elizabeth, eldest dau. of William Ponsonby, Viscount Duncannon; and d. in the

lifetime of his father, leaving an only son,

STEPHEN MOORE, Esq. of Kilworth, who was elevated to the peerage of Ireland, 14 July, 1764, as Baron Kilworth, of Moore Park, co. Cork; and created Viscount Mountcashell, of the city of Cashell, 22 Jan. 1766. His lordship m. Alicia, dau. of Hugh Colville, Esq., and heir of her brother, Robert Colville, Esq., by whom he had issue,

## Mineage.

This family, which derives its surname from Eggecomb, Egecomb, or Edgecomb, (as it has been variously written in old records,) in the parish of Cheriton-Fitz-Pain, near Crediton, was of great antiquity in the co. of Devon; when, in the reign of EDWARD III.,

WILLIAM DE EGGECOMB marrying Hillaria, dau. and heir of William de Cotehele, of Cotehele, co. Cornwall, removed to that place, and chiefly resided there. He d. in

1380, and was s. by his son,

WILLIAM EDGCOMB, Esq., who m. the dau, and heir of Denset. He had a grant, in the 6th HENRY V., with Robert Hethe, of the custody of the lead-mines, with the silver ore therein, which were in Devonshire. He left

PETER EDGECOMB, Esq., who m. Elizabeth, dau. and heir of Richard Holland, Esq., and was father of

SIR RICHARD EDGECOMB, Knt., a person of great eminence in the times of EDWARD IV., RICHARD III., and HENRY VII. In the 7th of the first-mentioned monarch, he served in parliament for Tavistock; and in the same year was escheator of the co. Cornwall, an office then of great trust. He subsequently joined Henry Stafford, Duke of Buckingham, against RICHARD III., and had a narrow escape for his life after the defeat and execution of that nobleman. But making his way into Brittany, he enrolled himself under the banner of the EARL OF RICHMOND, and

returning to England, participated in the victory of Bos-WORTH, and received the honour of knighthood from his victorious chief on the field of battle. He was afterwards sworn of the privy council, and appointed comptroller of his household by the new monarch. He obtained, likewise, grants of the castle, honour, &c., of Totness, and the manor of Cornworthy, with various other lands in the co. Devon, of which shire he served the office of sheriff in 1487. Sir Richard was subsequently sent into Ireland, "being a person (observes Sir James Ware) of singular prudence," to administer the oaths of allegiance and obedience as well to the nobility, gentry, and prime officers, as to the commonalty of the realm; and brought over with him 500 armed men. He m. Joan, dau. of Thomas Tremayne, Esq. of Collacomb, and had issue,

Piers, his successor. Margaret, m. to Sir William Courtenay, of Powderham. Agnes, m. to William Trevanion, Esq. of the co. Cornwall. Elizabeth, m. to Weymond Raleigh, Esq. of Raleigh.

Sir Richard d. in 1499, and was s. by his son,

SIR PIERS EDGCOMBE, K.B., who was sheriff of Devonshire in the 10th and 13th of HENRY VII. In the 5th of HENRY VIII., he was in the expedition against France, and was made a knight-banneret for his valiant conduct at the sieges of Therouene and Tournay, and at the battie of the Spurs. He m. Jane, dau. and heir of Stephen Durnford, Esq. of East Stonehouse, Devon, and was s. by his eldest son,

SIR RICHARD EDGECOMB, Knt., who served the office of sheriff of Devonshire in 35th of HENRY VIII. and 1st of MARY. He erected the stately mansion at East Stonehouse, called from him Mount Edgecomb, and was s. at his decease by his eldest son, (by his 2nd wife, Winfred, dau. of William Essex, Esq. of Berkshire,)

PETER EDGCUMBE, Esq., M.P. for the co. Cornwall, and sheriff of Devon, temp. ELIZABETH. He m. Margaret, dau. of Sir Andrew Luttrell, of Dunster Castle, in Somersetshire; and dying in 1607, was s. by his eldest son,

SIR RICHARD EDGECUMBE, who m. Mary, dau, and heir of Sir Thomas Cottle, of London, and was s. by his eldest son,

PIERS EDGECUMBE, Esq. of Mount Edgecumbe. This gentleman sat in parliament for Newport and Chelmsford in the reign of CHARLES I.; and in the words of the inscription on his monument, was "a master of languages and sciences; a lover of the king and church, which he endeavoured to support, in the time of the civil wars, to the utmost of his power and fortune." He m. Mary, dau. of Sir John Glanvil, of Broad Hinton, in Wilts; and dying in 1660, was s. by his eldest son,

SIR RICHARD EDGECUMBE, who was made one of the knights of the Bath previously to the coronation of King Charles II., in order to attend that ceremony. He m. Lady Anne Montague, 2nd surviving dau. of Edward, Earl of Sandwich, and was s. at his decease, in 1688, by his

only surviving son,

RICHARD EDGCUMBE, Esq. of Mount Edgecumbe. This gentleman was member for Cornwall in the time of King WILLIAM, and he sat for other places during the remainder of that reign and in the beginning of Queen Anne's. He was constituted one of the lords of the Treasury in 1716; and was elevated to the peerage, 20 April, 1742, as Baron Edgecumbe. His lordship was appointed, in the following year, chancellor of the Duchy of Lancaster. He m. Matilda, dau. of Sir Henry Furnese, Bart. of Waldershare, co. Kent; and dying in 1758, was s. by his elder son,

RICHARD, 2nd baron; who d. unm. in 1761, when the barony devolved upon his brother,

GEORGE, 3rd baron; who was created Viscount Mount-Edgecumbe and Valletort 17 Feb. 1781; and EARL OF MOUNT-EDGECUMBE 18 Aug. 1789. His lordship m. in 1761, Emma, only dau. and heir of his grace, John Gilbert, D.D., archbishop of York, by whom he had an only son, RICHARD, the present peer. The earl, who was bred to the naval service, and attained the rank of admiral of the Blue, d. 4 Feb. 1795, and was s. by his son,

RICHARD, 2nd earl, lord-lieut. and custos-rotulorum of the co. of Cornwall, b. 13 Sept. 1764; m. 21 Feb. 1789, Sophia, 3rd dau. and co-heir of John, 2nd Earl of Buckinghamshire, by whom (who d. 17 Aug. 1806) he had issue,

ERNEST-AUGUSTUS, Viscount Valletort. George, & 23 June, 1800; secretary of legation in Swit-
