MISCELLANEOUS.

THE LATE DR. JAMES BIRD.—The death of James Bird, Esq., M.D., late of the Bombay Medical Service, took place at Gerrard's Cross, Bucks, on the 10th July, in the 67th year of his age. This gentleman was educated at King's College, Aberdeen, and was admitted a member of the Royal College of Surgeons in duced. 1816. In 1818 he was appointed an assistantsurgeon on the Bombay establishment, and eventually became surgeon to the European General Hospital at Bombay; he was physiciangeneral of the Bombay Army from 1842 to 1847, when he retired from the Indian service. Royal Colleges of Physicians and Surgeons of England in 1844, and received the degrees of A.M. and M.D. from the University of Aberdeen in 1848. After his return from India he was appointed lecturer on Military Surgery, Tropical Medicine, and the Hygiene of Fleets and Armies, at St. Mary's Hospital, Paddington, and was elected a Fellow of the Medico-Chirurgical, Royal Geographical, Stasome time President of the Harveian Medical Society: he was likewise foreign secretary (for India) of the Epidemiological Society. The late Dr. Bird was known in the medical world as the author of the following treatises, viz., "The Principles and Practice of Military Surgery, Military Medicine, and Hygiene," and "What to Observe in Medicine, or the Means of Improving it as a Science and Art.' He had also contributed articles to various scientific journals, both in India and England, on guineaworm, cholera, tropical dysentery, and kindred subjects.

COLONEL W. P. WAUGH .- In the Court of Bankruptcy, on the 15th instant, before Mr. Commissioner Goulburn, an adjourned meeting for dividends was held in this matter. A question as to the right of the official manager of the Eastern Banking Corporation to prove for £250,000 has stood over from time to time, and it was now stated that the amount had been agreed on for which the proof was to be admitted, subject to his Honour's approval. It was also stated that the assignees had consented to allow the bankrupt £1 a week from the date of his surrender. Some discussion also took place with reference to a proof tendered by Messrs. Laurie and Marner, the well-known carriage-makers, of Oxford-street. Subsequently the parties concerned conferred with the commissioner privately respecting the claim for £250,000, and it was arranged that the meeting should be again adjourned in order that it might in the meantime be definitively settled for what amount the Eastern Bank should be allowed to prove.

PATTERN POST TO CEYLON AND HONG Kong.—A Post-office notice has been issued stating that on the 1st of August, next and thenceforward, patterns of merchandise may be transmitted by post between England and Ceylon and Hong Kong via Southampton and Marseilles. No packet of patterns must exceed two feet in length, breadth, or depth. The patterns must not be of intrinsic value, excluding all articles which have a value of their own, apart from their mere use as patterns. No other writing will be permitted than the address of the sender, a trade mark and numbers, and the prices of the articles. > THE "HYDASPES."-The East India and London Shipping Company's steamship Hydaspes, 2,249 tons, Captain G. H. Forster, has arrived. She left Calcutta April 8, arrived at Madras April 14, sailed again on the 22nd, arrived at the Cape on May 27, and sailed therefrom June 1. She brings about 140 cabin and thirty-four steerage passengers, among whom are Major Arbuthnot and Captains Graves, Styles, Briard, Robinson, and Wale. Her cargo includes linseed, rapeseed, rice, coffee, cotton, indigo, hides, shellac and wool. The Hydaspes brings also the following animals for the Zoological Society :- Three rhinoceros, an elephant, nine tortoise (of immense size), a young Indian cheta, hornbills in two varieties, cassowaries, tautilus, Javanese peafowl, lineated pheasants, one peacock pheasant, rufus-tailed pheasants, Indian cuckoos, and rose-coloured starlings.

> EXPORT OF SPECIE,-The India and China mail steamer Ceylon, which sailed on the 20th inst., took out specie to the value of £92,873, of which about £2,000 in gold and £15,000 in silver are for Madras, the residue, in silver, being chiefly for China and the Straits.
