EXECUTIVE DIRECTOR'S VIEW

CHRISTIAN LAMBRECHTS

For many, Kenya's important forest ecosystems, particularly the montane forests, are merely graceful, towering backdrops to our country's expansive landscapes. But those privileged to actually visit these forests experience so much more. They are places of incredible beauty and abundant flora and fauna.

But the wonders found in these forests are largely unknown to the public: most people associate Kenya's wildlife with open wooded savannah, while viewing forests merely as places from which to extract resources such as timber.

In reality, while closed-canopy forests cover less than 2% of Kenya's land area, they harbour a very high proportion of the country's biodiversity. Over 50% of Kenya's plant species are found in our forests. Significantly, these forests are habitat to 40% of mammal species, 35% of butterfly species and 30% of bird species found in the country.

The Aberdare forest hosts nearly 10% of Kenya's elephant population and about 60% of all the mountain bongo antelopes found in the world in the wild. Some 47% of the bird species and 54% of the butterfly species of Kenya are found in Kakamega Forest, which covers only 0.04% of Kenya's total land area. The five "Water Towers of Kenya" (Mt. Kenya, Aberdare, Mau Forests Complex, Cherangani Hills and Mt. Elgon) are all designated as Important Bird Areas and an astonishing 872 plant species have been recorded on Mt. Kenya to date.

Rhino Ark's established conservation work aims at protecting the rich biodiversity of the important forest ecosystems that are an integral part of Kenya's natural heritage. Our broad range of interventions have been customized to raise awareness and build capacity of the main custodians of these resources, namely the local communities and the Government conservation agencies. These interventions include conservation education, nature-based livelihoods, community-based patrols, training in fire-fighting, prosecution of wildlife and forestry crimes, aerial surveillance, natural forest rehabilitation, scientific research, and critically, construction of 795 kilometres of conservation electric fences to date.

More recently, Rhino Ark has embarked on the implementation of an eco-tourism programme to complement the above interventions. This growing programme aims to raise public awareness about the beauty and richness of important forest ecosystems, generate nature-based incomes for their custodians, and help to deter illegal activities. Our impactful programme is achieving tangible successes. In Eburu forest, we have developed a tourist guidebook, mapped out and signposted 15.6 kilometres of nature trails, and trained 9 community champions in birdwatching. In Northern Aberdares, we have trained and equipped 29 guides and porters, and mapped and marked 39 kilometres of nature trails.

MISSION, VISION AND KEY PRIORITY AREAS



Rhino Ark is a charitable trust established in Kenya in 1988 with the vision to restore and maintain harmony between humans, habitats and wildlife in Kenya.

To this end, Rhino Ark aims to be a trusted partner in advocating, developing and implementing high-impact forest, water catchments and endangered wildlife conservation initiatives that tangibly support adjacent local communities.



Rhino Ark's conservation programme is developed around six priority thematic areas:

1. Trusted Partner

Rhino Ark is the partner of choice in the long-term conservation of forests and their wildlife in Kenya.

2. Advocacy

Rhino Ark is a thought leader and senior advisor on forest and wildlife conservation in Kenya.

3. Innovation

Rhino Ark is a leader in the development and implementation of high-impact dynamic conservation solutions.

4. Forest and water catchment conservation

Rhino Ark develops and implements long-term management tools that protect and restore forest ecosystems and their water catchment values.

5. Endangered wildlife conservation

Rhino Ark develops and implements conservation interventions that protect and recover endangered forest species, including black rhino, mountain bongo and forest elephant.

6. Tangible community support

Rhino Ark develops and implements long-term solutions to human-wildlife conflicts, spearheads conservation education and champions conservation-based livelihoods within forest-adjacent communities.

CARBON NEUTRAL EVENT

Rhino Ark fully offsets the event's carbon footprint by purchasing Certified Emission Reductions (CERs) which go towards UNFCCC certified projects that reduce, avoid or remove greenhouse gas emissions from the atmosphere.

VOLUNTEER-RUN

The Rhino Charge is primarily run by volunteers. The Main Organising Committee consists of 11 members. They plan the event year-round and spend up to 2 weeks on site before and after the Charge. At the event itself, another 60+ volunteer officials give their time and expertise to ensure the smooth running of the event. Volunteers not only donate time, but considerable resources which help reduce the overall costs of the event.

Since the Rhino Charge is the guest of the host community, the Main Organising Committee places a lot of importance on, and devotes much of its time to, building good relations with the community involved. They also spend time finding and designing the route, plus planning how to provide good camping for up to 3,000 people, including planning water provision, medical facilities, airstrips and other key parts of the event.

4-5 AIRCRAFT



Search and Rescue (S&R) at the venue typically consists of:

- 4-5 Aircraft including fixed wing planes, helicopters and gyrocopters,
- 4-5 Cars in strategic positions,
- 1 Team at HQ monitoring positions of cars and co-ordinating with S&R Team over the radio.

The S&R team remains on duty until all people have been safely accounted for and recovered. At Nannapa Conservancy, the S&R team ended their shift at 4am in the morning after the Charge. Stuck, lost or broken vehicles are often recovered the next day.

The Rhino Charge is an annual off-road 4x4 competition held in Kenya in which competitors are required to visit 13 points (guard posts) scattered over approximately 100 km² of rough terrain within a 10-hour period. Entrants are supplied with a 1:50,000 scale map of the venue, co-ordinates of the 13 guard posts and their start position the night before the event. Each competitor team must plot the guard posts on the map and figure out their own route. The winning car is the team which visits the most guard posts in the shortest distance (GPS measured).

The event is organised in order to raise important funds to support the activities of the Rhino Ark Kenya Charitable Trust, which works towards the conservation and protection of Kenya's mountain range ecosystems, the so-called "Water Towers".

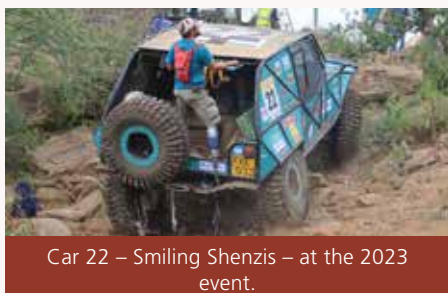

RHINO ARK KENYA CHARITABLE TRUST NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2023

1. SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of these financial statements are set out below:

(a) Basis of preparation

The financial statements summarise the transactions of the Trust and deal with the net assets at the disposal of the Directors. The financial statements are presented in Kenya Shillings (KES), which is the Trust's functional and presentation currency.

The financial statements are prepared under the historical cost basis of accounting except where otherwise stated in the accounting policies below.

(b) Income recognition

Donations and Rhino Charge collections are recognised on receipt.

Investment income is recognised on accrual basis.

(c) Property and equipment

Items of property and equipment are stated at cost less accumulated depreciation. Depreciation is charged on the straight line basis over the estimated useful lives of the assets.

The annual depreciation rates in use are:

Motor vehicles	25.0%
Furniture and fittings	12.5%
Computers	33.3%
Office equipment	12.5%

(d) Foreign currency transactions

Transactions during the year are converted into Kenya Shillings at the rates ruling at the transaction dates. Assets and liabilities at the reporting date, which are expressed in foreign currencies, are translated at the rates ruling at that date. The resulting differences from conversion and translation are dealt with in the income and expenditure account.

(e) Financial instruments

A financial instrument is a contract that gives rise to both a financial asset of one enterprise and a financial liability of another enterprise. The financial instruments held by the Trust are investments in the money market, trade and other receivables, bank balances and cash and trade and other payables.

All the financial instruments held by the Trust are accounted for on amortised cost basis.

(f) Receivables

Receivables are stated at nominal value, less provision for any amounts considered irrecoverable.

(g) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and in hand and short term deposits with an original maturity of three months or less.

(h) Use of estimates

The preparation of financial statements requires that management makes estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates. The more significant estimation process is related to the determination of provision for doubtful debts. Although some variability is inherent in these estimates, management believes that the amounts provided are adequate.

(i) Investments

Investments are held in the money market fund with Old Mutual and Britam asset managers. Interest is earned on a monthly basis from these placements and rolled over as principal.

(j) Payables

Payables are stated at nominal value.

The Trust has been granted exemption from taxation under the First Schedule to the Kenyan Income Tax Act (Cap 470) under Certificate number KRAEXM0096130722 valid from 15 February 2022 for 5 years.

Rhino Ark Kenya Charitable Trust was initially formed to assist the Kenya Wildlife Service (KWS) in building an electric fence along sections of the Aberdare National Park on its Eastern Salient area which has the highest concentration of Black rhino and borders directly onto farmland. The scope of the initial project then evolved into a much more ambitious programme.

Today, Rhino Ark is a leading Kenyan conservation organization that develops and implements practical solutions to the challenges affecting Kenya's mountain forests, also known as water towers, and their diverse wildlife, with a focus on threatened species. These solutions are high-impact forest, water catchments and endangered wildlife conservation initiatives that tangibly support adjacent local communities.

Overall funds 2022/23

The total funds raised during the financial year under review were KES 372.13 million. This included in-cash donations amounting to KES 220.43 million (2022: KES 157.77 million) from Rhino Charge, Corporates and individuals. In-kind donations amounting to KES 151.70 million was from international organizations, Government, various corporates, individuals and volunteers.

KWS covered the costs of the personnel maintaining the 400 kilometres Aberdare Fence and the 270 kilometres Mt. Kenya Fence already built whilst Kenya Forest Service (KFS) covered such costs for the 43.3 kilometres Eburu Fence. These contributions amounted to KES 26.62 million.

Corporate/conservation bodies support

We received several contributions from the following corporate and consensual grant supporters:

- M-Pesa Foundation for donating KES 3,625,000 for the maintenance of the Eburu Electric Fence;
- Wilder Institute/Calgary Zoo for donating KES 3,868,479 in support of forest conservation and community livelihoods towards the recovery of the Mountain Bongo antelope;
- Wildlife Conservation Society for donating USD 7,000 (KES 809,836) for the construction of an underpass in Imenti forest;
- European Union through the International Union for Conservation of Nature for

donating Euro 12,410 (KES 1,515,219) towards the maintenance of the Aberdare Fence;

- Platinum Credit for donating KES 11,202,056 in support towards reforestation in Southern West Mau Forest Reserve;
- Sustainable Trade Initiative (IDH) for donating Euro 14,185 (KES 1,922,068 million) for the activities at South Western Mau Forest Reserve;
- Total Energies for donating KES 783,348 in fuel credit in support of the Rhino Charge 2022 event;
- Darwin Initiative for donating GBP 99,833 (KES 13,934,012) for support towards the conservation of the Aberdare and South Western Mau forests; and,
- Eburu Rafiki for donating KES 357,000 in support of education outreach around Eburu Forest. This includes funds from Musiara Ltd, Governors Camp and several other donors.
- Various donors contributed for the guard post sponsorship at the rhino charge amounting to KES 3,100,000.

Mau Eburu Ecosystem

Fencing

Rhino Ark maintained the 43.3-kilometre long-Eburu Electric Fence, providing materials for maintenance and equipping (uniforms, tools, technical support) the 12-man fence maintenance team engaged by Kenya Forest Service. We further provided technical support for the fenced wildlife corridor that runs through Loldia Farm and links Eburu Forest to Lake Naivasha. To take stock of the impact of the fence and other interventions, Rhino Ark organized a 3-day strategic workshop on the Eburu Forest in October 2022. The workshop, organized jointly with Kenya Forest Service was attended by 40 participants from key stakeholder organizations. The workshop report provides an important formal baseline for the project.

Forest and wildlife habitat security

Our 6-man community scouts' team, working in collaboration with Kenya Forest Service carried out forest patrols that had the following outputs: 98 snares recovered; Sites for illegal activities detected charcoal (23), wood products harvesting (74), illegal grazing (11), grass harvesting (17); 6 arrests of suspects conducting illegal activities. Under the Rhino Ark / Calgary Zoo Mountain Forest Conservation Partnership, the long-term wildlife monitoring programme continues to document wildlife in the forest using 16 strategically placed trap cameras. This programme is providing comprehensive baseline data about wildlife species that will support future wildlife conservation interventions, including for the Mountain bongo antelope.

Rhino Ark continued to play a central role in coordinating and providing logistical support for firefighting work during the fire season, thus

helping to protect the forest. To build capacity for firefighting, a 5-day professional forest fire fighting training programme for a 22-member Eburu Community Fire Brigade was organized. The trainees received both theoretical and practical knowledge on how to fight forest fires. The training was funded by the Tusk Trust.

Community livelihoods

Rhino Ark facilitated a total of 9 on-farm training sessions for farmers from the local community. Practical, zone-specific lessons learnt by members included subjects ranging from farming best practices, soil and water conservation, installation and use of biogas. Seventy-two farmers have now fully adopted biogas within the ecosystem. A total of 194 farmers were direct beneficiaries of diverse training sessions provided by experts from the Ministry of Agriculture. Coupled with this was ongoing support for the community beekeeping project under the Rhino Ark / Calgary Zoo Mountain Forest Conservation Partnership: 36 community members received training in basic beekeeping at the National Beekeeping Institute. Twenty-eight members also participated in a study visit to a beekeeping project in Baringo County. Registration of the beekeeping cooperative was completed and the central processing plant was established at Eburu Forest Station with equipment valued at over KES 400,000 procured. The beekeeping cooperative now has 73 members.

South Western Mau Ecosystem

Forest rehabilitation

A total of 60 hectares of degraded indigenous forest were rehabilitated by Rhino Ark during the reporting period, with 77,000 seedlings planted. The work comprised 30 hectares at Tirigoi D, supported by Platinum Credit, and 30 hectares at Korabariet supported by the Darwin Initiative. The sites are secured using micro fencing, and each is guarded and maintained by community attendants. The two new sites join existing Rhino Ark maintained sites at Kipkoris (40ha), and Kapkembu (10ha).

Forest and wildlife habitat security

A new forest security outpost has been established at Korabariet with funding support from the Darwin Initiative.

This new outpost will provide a base for forest rangers and community scouts to carry out forest protection work in the northern sector of the Ndoinet forest block. The outpost also enhances security for the newly rehabilitated adjacent 30ha site. Nineteen collaborative forest patrols with Rhino Ark staff, community scouts and forest rangers recovered 22 snares, 14 timber posts and destroyed 24 illegal charcoal kilns within the reporting period.

Rhino Ark has procured equipment for 15 rangers (Kenya Forest Service and Kenya Wildlife Service) with forest hiking gear and camping equipment for extended forest patrols. The gear and equipment is enabling the rangers to carry out extended, multi-day security patrols deep

inside the forest. The patrols aim to address illegal human activities detected through the aerial surveillance programme spearheaded by Rhino Ark. The items will greatly assist in wildlife and forest protection work by the security teams.

Community livelihoods

With funding from the Darwin Initiative, we have initiated a new phase of the beekeeping project within the landscape. Community mobilization has been carried out and a baseline survey with 104 beekeepers commenced (completed in April 2023). Our outreach team is continuing to engage with the community through local churches, youth groups and other forums to sensitize the community about conservation. This drive is complemented by Rhino Ark's formal conservation education programme running in 46 schools within the landscape. Close monitoring of this programme is carried out by Rhino Ark's team in collaboration with officials of the Ministry of Education.

Mount Kenya Ecosystem

The Mount Kenya Electric Fence has been making good progress. Of the 60-kilometre-long phase of the fence in Nyeri County that was launched in November 2021, 45 kilometres have been built. This phase stretches from River Sagana to River Tigithi, along the forest reserve/community boundary. It is implemented through a public/private partnership between the Upper Tana Catchment Natural Resources Management Project, Kenya Wildlife Service, Kenya Forest Service, Rhino Ark Kenya Charitable Trust and Mount Kenya Trust. Support is also received from the Kenya Pipeline Company who provided KES 20 million through Car 23 and the Fresno Chaffee Zoo (USA). The activity is a continuation of the Mt. Kenya Electric Fence programme through which 275 kilometres of comprehensive fence have already been built.

The Imenti Forest, in the northeast of Mount Kenya, has been one of the most challenging forest areas fenced by Rhino Ark to date. This is due to elephant movement and fence breakage. Together with KWS and the Upper Tana Catchment Natural Resources Management Project, two additional elephant grids have been built, bringing the number of grids in the Imenti forest to four. These add to the 53 kilometres of double fences and the two one-way automatic elephant gates already built in the same area. Rhino Ark has also completed the technical design of an elephant underpass to be constructed on the Nanyuki-Meru Highway where it crosses the Imenti Forest. This forest has likely one of the highest concentrations of applied technology to enable elephant movement and human development side-by-side.

Through the Rhino Ark – Wilder Institute / Calgary Zoo Mountain Conservation Partnership and in collaboration with other partners, Rhino Ark has made great progress towards the re-introduction of Mountain Bongo antelope in Ragati and Chehe forests in the south-western

part of Mt. Kenya. A Mountain Bongo Expert Advisory Committee comprising of international and national advisors has been assembled to provide technical advice on veterinary, re-introduction, and ungulate translocation issues. The Committee held its inaugural meeting in October 2022. A feasibility study was prepared and finalized, as well as an environmental impact assessment study. Two prior informed consent processes were conducted in Ragati and Chehe forest stations. The management plan for the re-introduction is also nearly completed. To ascertain the remnant population of the Mountain bongo in these forests, as well as the population of other wildlife, camera traps have been set up in these forests.

Aberdares Ecosystem

Maintaining the 400-kilometres-long electric fence remained a priority area for Rhino Ark. This is a critical activity to deter poachers, illegal loggers, and charcoal burners as well as forest encroachment but largely to protect forest-adjacent communities from marauding wildlife. Fence maintenance received support from European Union's Biodiversity and Protected Areas Management (BIOPAMA) to run our fleet of fence vehicles, procure new uniforms for the 114 fence attendants and purchase fence tools and fence materials.

This year's Aberdare Relay Run was also supported by the European Union's BIOPAMA. The Run aims to raise awareness among young people living around the Aberdare ecosystem of the importance of conserving this critical water tower, which provides most of the drinking water for Nairobi and population centres located around the Aberdare ecosystem.

Rhino Ark secured a large grant from the Darwin Initiative to boost conservation efforts in the north-western part of the Aberdare. With Darwin support, Rhino Ark procured fence material to close the 10-kilometre gap that was left at the bottom of the Wanjohi-Shamata escarpment. A survey of some of the most degraded forest areas was conducted and a tree nursery established to support replanting. Training and gears were provided to the Guides and Porters Association based in Geta to promote eco-tourism in the area.

Wildfires have been a major concern in the Aberdare. Several fires affected various parts of the moorlands from Kinangop to Shamata. In February 2023, a major fire broke out and spread across the central moorlands destroying approximately 40,000 acres of vegetation. Resources were mobilized from Rhino Ark, KWS, KFS, Mount Kenya Trust, National Youth Service and the Kenya Pipeline Company to contain the fire.

Kakamega Forest Ecosystem

Rhino Ark spearheaded the setup of a strong partnership to conserve and fence Kakamega Forest. The partnership includes Rhino Ark, KFS, KWS, National Environment Trust Fund

(NETFund) and the county governments of Kakamega and Vihiga. A partnership agreement and a fence implementation agreement were signed between the partners on 24 February 2023. This follows the undertaking of the Environmental and Social Impact Assessment study for the fencing of Kakamega Forest, financed by Rhino Ark. A NEMA licence was issued after the successful submission of the study report.

Funding from UNDP to build the first 15 kilometres of fence was secured by Rhino Ark. Disbursement was made through NETFund who procured and delivered the fence material in December 2023. The Kakamega Forest Fencing and Conservation was officially launched by Hon. Soipan Tuya, Environment Cabinet Secretary on 24 February 2023.

Rhino Ark UK and Rhino Ark USA

Over the past year, we have been working towards strengthening Rhino Ark US and Rhino Ark UK. Rhino Ark US has expanded its Board with the addition of two new members: Dr. Paul Reillo and Mark Somen. With the in-kind support of Ballantines PR, we have been pitching the stories of Rhino Ark and Rhino Charge in the US market towards securing donations. In the UK, the branding and social media channels of our sister charity have been revamped. A professional fundraiser has been contracted in the US, while in the UK a fund-raising committee has been working towards securing grants. As of 31 March 2022, Rhino Ark US and Rhino Ark UK were holding USD 187,425.59 and GBP 33,908.77 respectively, from Rhino Chargers' online sponsorships as well as from grants.

Thousands to thank

There are many individuals and organizations, both local and international, who have contributed to our conservation triumphs in this past year. While it may not be possible to mention each one here, we at Rhino Ark deeply appreciate and treasure their support. We do not take it for granted, and it is the sacrifices, support and input of each one that have collectively ensured that Kenya's critical forests and water towers remain secured for another year through our fences, conservation programmes and advocacy.

I wish to acknowledge and thank the Rhino Charge Community – officials and volunteers. Their energetic efforts, skill and innovation in running this exceptional annual event continue to set new benchmarks and enable competitors to participate and raise the funds that support Rhino Ark's paradigm shifting work to be carried out.

I would also like to appreciate the staff of Rhino Ark and the Board members who continue to provide day to day operational support to keep our organization going forward.

Bringing the Mountain bongo back from the brink of extinction

Mountain bongos in zoos in Kenya and around the world are playing a crucial role in efforts to save wild populations from extinction. New members of the species are being bred in the zoos for later release in the wild.

The endangered Mountain bongo, found exclusively in Kenya, is on the brink of extinction with fewer than 80 individuals left in the wild across four ecosystems.

Poaching and habitat loss are two of the main reasons causing dwindling numbers of the antelopes and Rhino Ark is also working to address these challenges. The Mountain bongo is at home in the indigenous forests of Mt. Kenya, the Aberdares and the Mau Complex.

Rhino Ark is engaging communities around these ecosystems in a bid to save the rare antelope scientifically known as *Tragelaphus eurycerus isaaci*. Camera traps and GIS maps are being used in Mt. Kenya and Mau Eburu to study bongo demographics including population size and ranging patterns in addition to protecting their habitat.

Our ultimate goal is to recover the Mountain bongo species to their former glory, roaming Kenya's mountain forest slopes in large and healthy wild herds. To meet with success, we work closely with community stakeholders to bring about tangible forest-friendly economic benefits and establish bio enterprises to add value to local industries.

Citizen surveys with forest-adjacent households help us to better understand attitudes toward the forest environment, to conservation and to mountain bongo in particular. Building from this research, we are able to implement locally relevant programmes to meet with the greatest degree of success for people.

Complex conservation problems can only be solved with collaboration. We work with government, community, NGOs and private partners. We would like to acknowledge and thank Kenya Wildlife Service, Kenya Forest Service, Wilder Institute / Calgary Zoo, Bongo Surveillance Project, Mt. Kenya Trust, Eburru Rafiki, Ragati River Management, and the Eburu, Ragati and Chehe Community Forest Associations for their dedication to collaboration.

Rhino Ark was part of a recent stakeholder meeting in Ragati forest, reflecting on two years of dedicated efforts to recover the Mountain bongo. The meeting emphasised collaboration, progress, and the collective commitment to safeguarding biodiversity.

Rhino Ark also conducted a survey on the mountain bongo targeting secondary school students near Ragati and Chehe Forest blocs, which are located in the southwest of the Mt Kenya water tower ecosystem. The survey aims to gather information about the environmental knowledge of the youth in the area. Some 200 questionnaires out of a target of 300 were completed.

Rhino Ark aims to assess the students' familiarity with the Mt Kenya forest and the critically endangered antelope species. The findings from the survey will play a vital role in shaping environmental education programmes and developing lesson plans for the Rhino Ark Wildlife Club.

By understanding the level of awareness and knowledge among the local youth, we can design targeted initiatives to enhance their understanding of the importance of conservation and the need to protect the natural resources in the region.

As a forest dependent flagship species of Kenya's remaining mountain forests, the bongo is in need of immediate protection and population recovery.

Boda Boda riders trained on conservation and road safety

Forty-eight Boda Boda riders around the Eburu ecosystem were trained on conservation and road safety in June 2023.

The training, at Eburu forest station, marked the launch of the joint Rhino Ark and National Transport Safety Authority (NTSA) community conservation champions programme.

The riders completed Module 1, a two-day training course covering topics on conservation, taught by Rhino Ark and road safety, taught by NTSA.

The chief guest for the launch event was Jean Todt, United Nations Special Envoy for Road Safety.

The riders received UN standard motorcycle helmets, donated by Mr. Todt, and high visibility reflective riding vests, provided by Rhino Ark.

With the knowledge provided to them, the riders will help to propagate good practices in road safety and conservation within their respective communities and amongst their boda boda operator peers. They will help to drive positive change through leading by example.

The programme has a long-term approach: it will provide progressive learning experiences for the riders through continuous engagement between them and mentors from Rhino Ark and NTSA, under a conservation champions framework established by Rhino Ark.

This collaboration offers a holistic approach that not only protects lives but also empowers local communities to actively participate in preserving their natural heritage.

A newly-trained Joint Surveillance Unit had a feel of the work ahead of them by camping in the South Western Mau forest for three days. The eight members were accompanied by Kenya Forest Service (KFS) officers from Ndoinet Forest Station. The team conducted robust and successful forest patrols in Kusumek area, destroying charcoal kilns, making arrests and de-snaring.

The Darwin Initiative provided much needed funding to support this community scouts programme that is vital in safeguarding our delicate ecosystem.

The unit was trained at the Kenya Wildlife Service Law Enforcement Academy. On graduation, they are required to undertake foot patrols in some of the most isolated locations within

the South Western Mau ecosystem, featuring inconceivable gradients and poor weather.

In order to raise community knowledge and sensitisation on conservation, JSU will also serve as Conservation Champions. In an effort to bring people, wildlife and the forest into harmony, they will keep building bridges and giving local communities conservation awareness.

Outpost an antidote for forest destruction

Rhino Ark has officially handed over the newly-constructed Bosto forest outpost to the Kenya Forest Service (KFS). The outpost is situated within the Itare Forest Station of the South Western Mau Forest Reserve, a notorious hotspot for illegal activities due to the absence of rangers.

The establishment of the outpost will enable KFS to deploy a team of five rangers. The rangers will conduct regular patrols acting as a strong deterrent against illegal activities such as grazing, logging and charcoal burning, thereby significantly enhancing the security of the forest.

Joseph Kingori, the Bomet County Forest Coordinator, received the outpost during a ceremony attended by the local community, representatives from the Nyayo Tea Zones Development Corporation, and government officials, including the area chief and sub-chiefs.

The construction of the Bosto outpost was made possible by Rhino Ark, with funding support from The Darwin Initiative.

Rhino Ark's strategic approach to forest protection involves providing essential infrastructure like this outpost. The organisation has constructed four forest outposts along the South Western Mau Forest boundary, covering the counties of Kericho, Bomet, Narok and Nakuru.

Overflight reveals illegal activities in South Western Mau

A joint surveillance flight over the South Western Mau was conducted on November 3, 2023 to observe illegal activities in the forest. The flight was comprised of a team from Kenya Forest Service, Kenya Police, The Judiciary and Rhino Ark.

An after flight debriefing meeting in Kericho town discussed the observations and agreed on action points. The geo information science (GIS) data collected during the flight will be compiled and shared with ground operations teams for follow-up actions.

The surveillance flights programme, coordinated by Rhino Ark, plays a crucial role in the forest protection strategy by enabling the detection of activities that might otherwise go unnoticed in the vast forest.

GIS technology to boost forest restoration

Rhino Ark is hoping to partner with Silvi Earth, a geo information science (GIS) technology firm to conserve forests. This emerged after a team from Silvi Earth visited South Western Mau to evaluate the level of success in Rhino Ark's forest restoration work.

Silvi Earth uses the Silvi App to track the health and wellbeing of planted trees and share their growth progress. The app registers individual trees at rehabilitation sites and groups them together to show the reforestation zone.

Rhino Ark is looking to use the technology to gain a deeper understanding of forest dynamics and protect the newly rehabilitated sites in the South Western Mau ecosystem.

The dynamics of the technology blended with art and design are projected to influence Measurement, Reporting and Verification (MRV), which is an important system aimed at improving rehabilitation productivity, accountability and minimising supervision time.

Technology has proven to be a game-changer in the crucial task of sustainable forest management. Satellite data and drone images, among other cutting-edge tools, have revolutionised the way we track and monitor forest rehabilitation, changes to the forest area and identify different tree species.

With every passing day, technology is becoming increasingly crucial for forest management and conservation, leaving no doubt that it is here to stay.

Indigenous trees planted at 30-hectare Tirigoi site

A total of 33,000 trees were planted during the launch of the Platinum Credit-sponsored forest rehabilitation project at Tirigoi Site D. The 30-hectare site was identified and mapped jointly by the Kenya Forest Service, Rhino Ark and the Community Forest Association (CFA).

To protect the seedlings from potential damage caused by livestock or human activity, a micro fence was constructed using six-strand barbed wire on main posts with a spacing of 2.5 metres.

Additionally, dropper posts were installed, with 13 droppers placed between each main post. The indigenous tree seedlings were sourced

from local communities and in accordance with specifications provided by the Ndoinet Forest Station Manager.

Rhino Ark is overseeing the maintenance of the site for a period of three years, employing two on-site community scouts who will work under the supervision of the forest manager and Rhino Ark.

The maintenance activities will include periodic spot weeding and bush clearing to ensure the survival of the newly planted seedlings.

Car 19 and WhiteCap visit Mt Kenya fence project

A team from WhiteCap and Captain Petra Somen's Rhino Charge Car 19 (Bushbabes) visited the Mt. Kenya ecosystem's recently finished 60-km electric fence line.

The purpose of the October 5, 2023 tour was to evaluate how well Rhino Ark's solar power system was working to reduce conflicts between people and wildlife.

WhiteCap has provided funds through Car 19 for Rhino Ark to carry out some of its projects in the water towers we work in. In total, Car 19 has given Rhino Ark approximately KES26 million, which has been used for conservation efforts.

The generosity of our contributors, partners and sponsors is what enables Rhino Ark to carry out its conservation efforts.

Caught on camera

In June and July, our camera traps positioned in the southwestern corner of the Mt. Kenya Forest Reserve and National Reserve recorded a diverse array of wildlife, including both large and small creatures.

Among the notable sightings were the Suni, as well as a pair of young Honey badgers. Additionally, elephant herds were frequently observed.

Sagana-Tigithi fence project nears completion

The 60-kilometre Sagana-Tigithi section of Mt Kenya Forest Electric Fence project is about to be completed. The Fence Technical Committee recently inspected the project near Sagana State Lodge.

The fence is supported by Rhino Ark, Kenya Wildlife Service, Kenya Forest Service, Upper Tana Natural Resources Project and Mount Kenya Trust. Kabaru, Hombe and Naru Moru Community Forest Association host the project.

Meanwhile, repairs were carried out on the steel lockable gates installed along Phase 1 of the fence. Broken gate hinges at Muthigi Gate and Rutune Gate were replaced.

Rhino Ark is dedicated to ensuring the effectiveness and durability of the Mt Kenya Electric Fence, and these repairs are just one example of our ongoing commitment to this important conservation project.

Survey reveals botanical secrets of Ragati forest

A team of botanists, ecologists and nature enthusiasts is carrying out a floral survey of Ragati forest on the slopes of Mt Kenya.

Led by the esteemed Dr. Quentin Luke, the team has reported incredible progress as it delves deep into the captivating forest to unravel the secrets of its unique ecosystem.

A total of 321 distinct plant species have so far been identified, each contributing to our understanding of the astonishing biodiversity that flourishes within Ragati Forest.

Tree planting holiday helps restore degraded ecosystems

Rhino Ark, in partnership with the Mount Kenya Conservation Forum, Kenya Forest Service and Kenya Wildlife Service, planted 12,000 assorted indigenous trees in the Mt. Kenya ecosystem.

The tree planting event took place in Gathiuru Forest, Gakawa location. It came after the government declared Monday, November 13, 2023, a special holiday in which people nationwide were expected to plant trees to help with the country's land restoration efforts.

It was part of Kenya's Landscape and Ecosystem Restoration Programme, which aims to grow and nurture 15 billion trees by 2032 to restore and conserve 10.6 million hectares of degraded landscapes and ecosystems.

The Mt Kenya tree planting was led by Ms Alice Wahome, the Cabinet Secretary for the Ministry of Lands, Public Works, Housing and Urban Development.

Other guests present included Rhino Ark

Executive Director Christian Lambrechts, Nyeri County Governor Mutahi Kahiga and Kieni MP Wainaina Anthony Njoroge. Partner organisations present included Mt. Kenya Conservation Forum, Kenya Air Force, Mau Mau Original, National Youth Service, Kenya Police, Kenya Prisons, NACADA, Local Administration led by the Central Regional Commissioner, and the local community.

Ms Wahome said President William Ruto's government had rolled out an "All Government, All People Approach" to growing trees to save the country from the adverse effects of climate change.

The event was aimed at fostering environmental awareness and sustainable practices. The CS encouraged Nyeri residents to actively participate in reforestation areas like Gathiuru, previously impacted by human activities.

In his speech, Mr Lambrechts said Rhino Ark had invested KES 4 billion in the conservation

of Kenya Water Towers over the past 34 years. Additionally, Rhino Ark had built and maintained 754 kilometres of electric fences, which address key challenges facing these ecosystems, including human-wildlife conflict and illegal forest resource destruction.

Joint surveillance units get practical tips in Nyeri training



Collaboration in Conservation
Highlights from the Rhino Ark Joint Surveillance Training.

Members of surveillance units from the Aberdares, South Western Mau and Kenya Forest Service gathered at the Wildlife Research & Training Institute in Nyeri for training.

The 25 participants were trained by Rhino Ark staff. The curriculum included:

- (i) a general overview of Rhino Ark;
- (ii) strategies for improved collaboration among Kenya Forestry Service, Kenya Wildlife Service, and Rhino Ark;
- (iii) discussions on safeguarding policies;
- (iv) use of digital cameras and GPS for navigation;
- (v) insights into deploying camera traps;
- (vi) guidelines for general forest patrols; and
- (vii) practical sessions on pitching up and dismantling tents.

Tender care for Geta forest tree nursery

Personnel from Rhino Ark, the Kenya Wildlife Service and dedicated community members were at the Geta Forest Station to help care for seedlings in its nursery. The visitors helped to prick out, weed and ensure proper watering for each of the 80,200 seedlings in the nursery. In addition, they took steps to safeguard water supply by building dykes for water pipes.

This noteworthy project has received support from Biodiversity Challenge Funds, which underscores its significance in advancing environmental conservation and sustainability. The collaboration between conservation organisations, local communities, and the backing of the Darwin Initiative exemplify our collective dedication to preserving biodiversity and safeguarding Kenya's forest ecosystems.

Personnel from the Kenya Forest Service also participated in transplanting the seedlings, weed control, watering and propagation of locally sourced seeds. Seedlings from the nursery were planted in the Sophia area during the previous tree planting season, while others are primed for the upcoming forest rehabilitation season.

Meanwhile, a team from Geta received training from the Kenya Forestry Research Institute (KEFRI) on the cultivation of ceremonial trees. This training encompassed various aspects, including seed collection, processing, storage and techniques for overcoming seed dormancy.

The Rhino Ark tree nursery is raising *Hagenia* trees using seeds collected from the forest reserve.

Darwin Initiative supports the construction of a 10-km fence in Shamata to deter cedar loggers



Aberdares 10km fence project posts delivered.

Posts for a 10-kilometre stretch of fence in the Aberdares have been delivered to the site and are ready for the construction phase.

The project, supported by the Darwin Initiative, aims to bridge a 10km gap in the Aberdare fence. The construction had previously stopped at the cliff section extending from Gitobu in Shamata to Rayetta in Wanjohi.

While the cliff has effectively contained wildlife within the protected area, there has been an issue with illegal cedar loggers who have found a way to extract timber and produce charcoal, posing a serious threat to the cedar trees in the River Malewa catchment.

Road repairs to break fires in the Aberdares

Roads in the Aberdares national park that have been disused for years will be reopened to ease access for fire fighters and tourists. Rhino Ark Executive Director Christian Lambrechts and senior KWS officials toured the park to survey the targeted roads.

Re-opening the roads will help establish new firebreaks; ease access for firefighting teams and provide access to visitors to experience the beauty

of the central moorlands that have been inaccessible for decades.

The team also did a recce to identify the alignment of a new road that would prevent fires in the northern moorlands spreading into the central moorlands, as it happened in March 2023. This follows deskwork undertaken by Rhino Ark to identify passages used by fires to move from northern moorlands to central moorlands.

Phase 1 of 117-km Kakamega forest fence complete

The first phase of the Kakamega Forest Fence Project supported by the Government of Japan through UNDP has been successfully completed.

The 117-km project which is in four phases aims to protect the unique and fragile biodiversity of Kakamega Forest. This will also help reduce human-wildlife conflicts and promote ecotourism development for socio-economic growth.

Project partners that have collaborated in the project include the Ministry of Environment, Rhino Ark Kenya, County Governments of Kakamega and Vihiga, NetFUND, UNDP, Kenya Forest Service, Kenya Wildlife Service, Embassy of Japan and local communities around the forest.

The project's senior management committee conducted an assessment of the initial stretch of the live fence, spanning 15.4 kilometers, which terminates at Shenyende.

Subsequently, the committee met to deliberate on their observations and discuss the outcomes of the inspection. Separately, a senior team from Mpesa Foundation also visited the project on July 6, 2023 to meet with project partners.

Mpesa Foundation's support, coupled with funding by the other partners, will see completion of Phase II of the project. The Foundation has given the project a KES 60 million grant. This support through Rhino Ark will go towards

construction of the 35-km long Phase II of the fence.

The timely entry of Mpesa Foundation as a funding partner comes after completion of the 15-km Phase I of the fence from Isecheno to Kakamega showground.

The Foundation's support will also enable commencement of complementary community-based activities, including the conservation education programme.

This support is highly significant, marking the entry of the Kenyan corporate sector as a key partner in conserving this critical ecosystem.

Eburu fence protects farmers' crops from wildlife

The establishment of the Eburu Fence by Rhino Ark has brought about positive outcomes for farmers residing near the forest. This forest harbours a variety of wildlife species, some of which have caused harm to crops in the past.

Serving as a physical barrier, the fence effectively prevents wildlife from encroaching upon agricultural land and causing crop damage. By segregating the forested region from the farmland, the Eburu fence has addressed conflicts between humans and wildlife. This

has enabled local farmers to concentrate on their agricultural pursuits without the perpetual concern of wildlife-related damage or threats, leading to enhanced productivity.

For each ecosystem in which we work, fence maintenance procedures and routines have been established, and personnel have been provided to undertake constant maintenance of the fences.

A fence attendant recruited from the forest-

adjacent communities maintains each successive four-kilometre-long fence section continuously. Supervisors monitor the maintenance work of the fence attendants. A Fence Technical Committee that meets monthly and comprises the main partners that built the fence regularly reviews the status of the fence.

The Handbook of the Management of Electric Fences guides the overall maintenance and management of the fences.

The bags will be used by fence scouts who manage the fence daily to carry their tools of operation. The donation was officially handed

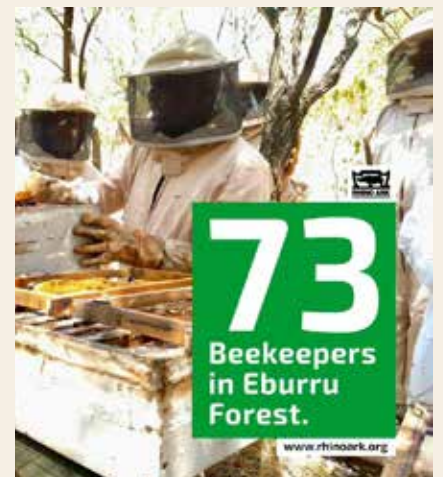
over to Rhino Ark on September 19, 2023 by Sandstorm Marketing Officer, Brenda Wangui.

Rhino Ark equips them with skills that enable them to actively engage in environmental education in local communities. These are:

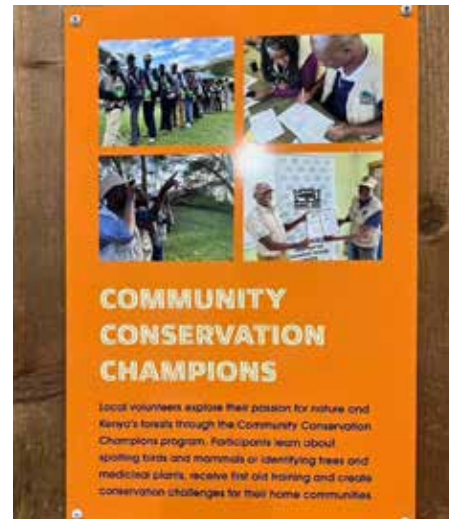

Community scouts complete KWS training

Eight Rhino Ark community scouts graduated from the Kenya Wildlife Service Law Enforcement Academy in Manyani on November 2, 2023. The scouts, who were recruited in August 2023, make up the core of our newly established South Western Mau Joint Surveillance Unit (JSU).

The scouts will be deployed as a permanent team in place to carry out regular forest patrols jointly with Kenya Forest Service and Kenya Wildlife Service rangers. They will find and remove wildlife snares and traps, disrupt illegal

activities such as logging, charcoal burning and livestock grazing. They will also be ambassadors of conservation in their respective forest adjacent communities.

The three-month community rangers conservation certificate training they have completed has armed them with a comprehensive mix of skills and discipline to professionally carry out conservation work within the South Western Mau forest landscape.

Of the 70 graduates drawn from diverse conservation areas and institutions, our team distinguished themselves by scooping two of the three personal awards on offer. Jesca Chepngeno and Leonard Kipkirui earned "Best in Drill and Turnout" honours for Ladies and Men respectively.

We are proud of our scouts for their successful completion of the grueling course.



Ogieks get help to add value to forest products

Rhino Ark has entered into agreements with various stakeholders for sustainable management of Ndoinet forest.

The Participatory Forest Management Plan (PFMPs) and the Forest Management Agreements were launched in collaboration with Kenya Forest Service, the South Western Mau Ogiek and Ndoinet Ogiek CFA in Bomet County.

The PFMP provides a five-year framework to guide forest conservation and sustainable livelihood development through activities such as livestock keeping, grazing, tree nursery establishment, herbal medicine extraction and beekeeping for the CFA.

The indigenous Ogiek community of the South Western Mau forest ecosystem has a long tradition of beekeeping and using herbal medicines from the forest to treat various ailments. However, they have not yet been able to build on this knowledge to further improve their incomes.

Ms. Charity Munyasya, the acting SDCCF for Strategy, Partnerships and Resource Mobilisation who was the chief guest applauded the community for their great effort in conserving the wider South Western Mau forest.

Rhino Ark's community conservation work

initiated in 2017 has resulted in constructive engagement with the Ogiek, some of whom have already benefited from our honey production training since 2018.

This engagement is enabling the development of conservation-based livelihoods among the community. Our initiative is now extending further to upskilling in value-addition processing and marketing of herbal products.

This will enable the Ogiek community to build on their traditional knowledge and derive economic benefits while, in turn, participating further in forest conservation.

Ragati CFA office nears completion

The construction of the Ragati Community Forest Association (CFA) office at Mount Kenya is in the final stages. The office is funded by Rhino Ark and the Wilder Institute Calgary Zoo.

It will empower community members to more effectively oversee and manage their forest-related activities.

Recruitment of Mt Kenya fence workers

Fourteen more primary schools have been enrolled into the Rhino Ark Conservation Clubs programme in Mt. Kenya.

Pupils in the schools will now benefit from Rhino Ark's educational classes on wildlife conservation.

Rhino Ark trustees have conducted two successful fundraising events in the United Kingdom and the United States. Funds were raised at a dinner and silent auction.

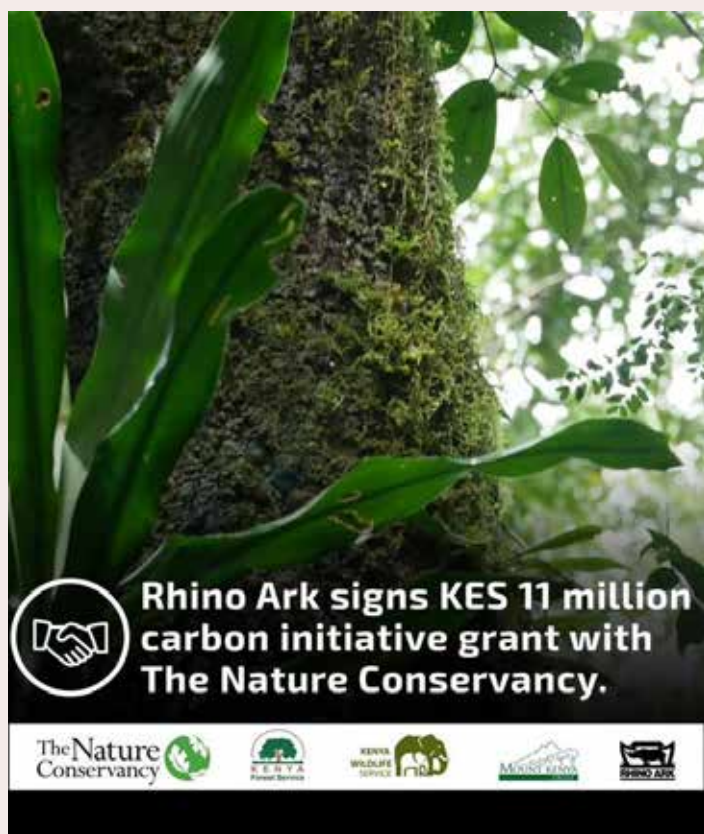
The UK event featured notable speakers including Lord Aberdare and Kenyan High Commissioner Manoah Espisu.

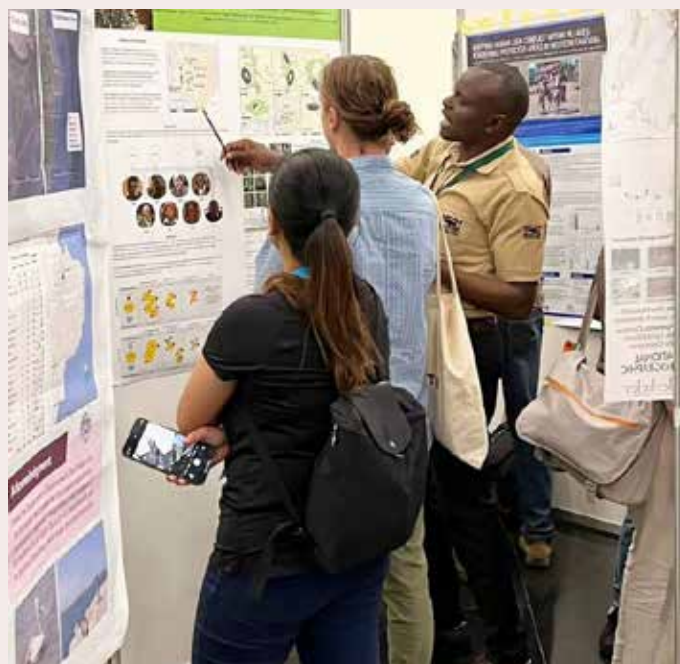
Bongo hunters research findings shared at global Biology congress in Kigali

Rhino Ark attended the International Congress for Conservation Biology 2023 in Kigali, Rwanda, at which it shared findings of a study on bongo hunters. Mr Solomon Wachiuri and Dr. Donna Sheppard led a successful scientific poster session.

They presented the outcomes of Rhino Ark's Traditional Ecological Knowledge (TEK) Study, which involved interviewing historical bongo hunters to gather crucial insights supporting the recovery of the bongo species.

The data collected from eight individuals was highly consistent, instilling confidence in the information shared. The TEK is expected to play a pivotal role in informing and guiding effective bongo recovery programmes in Kenya.

The conference's theme, "The future is now: Sustaining Biodiversity for Today and Tomorrow," attracted 1,200 participants from 93 countries, creating a global platform to exchange valuable conservation knowledge.

1. Fencing programme

Our comprehensive game-proof electrified fences help secure prime indigenous forests and resolve human-wildlife conflict, keeping forest-adjacent communities engaged in conservation. One kilometre of electrified fence costs KES 2.5 million (US\$ 25,000). Once built, fences must be maintained continuously and we deploy 174 fence attendants maintaining our fences on a daily basis, supported by eight 4x4 vehicles. Fence maintenance costs KES 80,000 (US\$ 800) per kilometre per year.

2. Endangered species and forest conservation

Support our community-based patrol programme:

The Aberdare Joint Surveillance Unit (AJSU) is an elite, seven-man team of community scouts that patrols the Aberdare ecosystem. AJSU targets illegal activities such as logging, charcoal kilns, snaring and wildlife trapping. The team also monitors wildlife abundance and distribution, gathers intelligence information, and participates in forest fire fighting. KES 73,500 (US\$ 735) can cover a two-week field mission.

In Eburu, a five-man Foot Patrol Team responds to local intelligence reports to carry out highly-skilled operations to catch would-be wildlife or forestry criminals. Their main targets are wildlife snares, illegal logging and charcoal kilns. KES 24,000 (US\$ 240) can cover a two-day field operation.

Support forest rehabilitation:

Large areas of prime mountain forest habitats degraded by illegal human activities and forest fires, need to be rehabilitated. Donate to help restore our mountain forests. KES 100 (US\$ 1) will enable planting and caring for a tree seedling.

3. Community conservation and livelihoods

Our community programmes are geared towards reducing forest-adjacent communities' reliance on forest resources, improving their livelihoods, and raising their environmental awareness. These interventions result in their engagement in forest conservation, adoption of on-farm best practices and improvement of incomes.
